BREAKOUT SESSION TRACKS

Breakout sessions provided on Wednesday will consist of **general topic sessions** for all participants and **topic-specific tracks** for targeted audiences.



PDE/BCTE Projects and Updates Track	This track is designed for all participants with a focus on the future of CTE and updates on CATS, APTE Review, Perkins, TAP, and other BCTE initiatives.
Finance and Human Resources Track	This track is designed primarily for CTE Business Administrators/Managers and will focus on updates for CTE school business offices.
Information Technology Track	This track is designed primarily for CTE Technology Coordinators and will focus on technology in CTE.
Building Level Administrators Track	This track is designed primarily for CTE Assistant Directors, Principals, and Supervisors with a focus on issues related to the administration of secondary CTE programs.
Facilities Track	This track is designed primarily for CTE Facilities Directors and will focus on facilities in CTE.
Student Services Track	This track is designed primarily for CTE School Counselors and will focus on increasing access for students to CTE and assisting them in the transition to careers and postsecondary education.
